Jerry spent nearly 50 years in the industry and spent time with Siegrist Companies, 25 years with Western Paving Company, and his last 21 years with Bituminous Roadways/CAMAS/Aggregate Industries WCR.

Jerry worked on all size projects from small parking lots to major projects like DIA, I70 and I-25 from Fort Collins to Pueblo and from the Continental Divide to Limon. He was always proud of the work being done by the people he supervised and worded with. He was the driving force behind the companies he worked for receiving many "Best in Colorado" asphalt paving awards. LabCAT Goes on the Road to Durango

2018 takes the LabCAT Certification program back to Durango. In 2015 the management team at CDOT made a decision to put as many of their employees on the three-year cycle to have them eligible to re-certify when the LabCAT program returned in 2018. The program is open to all who are seeking certification or re-certifying for LabCAT Levels, A, B, C E and Inspector. Region 5 CDOT hosts this week-long session and gives up their facilities to allow for the certifications proficiencies to be conducted. There are many other volunteers who help during the week in addition to CDOT employees.

A grand thank you to CDOT Region 5, Pat Murphy and Tm Webb and the entire Region 5 Materials staff for coordinating this session, as well at Diane Hammond in the RMAEC office for preparing the documents and shipping all of the required information to Durango.



2018 Local Agency Pavement Condition and Funding Summary Data Available



CAPA has published the 2018 Local Agency Summary Pavement Condition Report and it is available to download from the CAPA website. Across the state there are 88,000 lane miles of asphalt and Local Agencies are responsible for funding and maintaining 74% of that network (over 65,000 lane miles). Seventy-one agencies have provided street funding and condition data in the 2018 edition. Agency feedback has been very supportive "Thanks for taking the time to compile all of this information, it is very useful, Summit County", "Thanks for sharing other agencies responses so we can see where we are, Adams County" "Thank you for continuing to put this together, Jefferson County". Of the 47 agencies that reported both 2017 and 2018 data, 65% reported an increase in their streets budget (+43.5M), 2% reported the same budget and 35% reported a decrease (-\$13.1M). Budget data also indicates that Capital Project spending is up 21%, Mill & Overlay programs have increased +19% and Maintenance Programs have increased +12%. Agencies are reporting that over \$247M has been budgeted for

2018 Annual Street Improvement Programs with an additional \$187M in Capital Projects....that's a total of over \$435M being spent by Local Agencies this year on streets and infrastructure across Colorado. CATEGORY - City Street New or Reconstruction

The City of Grand Junction and local paving contractor United Companies have been recognized with a "Best in Colorado" Quality Award in the City Street New or Reconstruction Category for their Riverside Parkway project in Grand Junction.


This \$2.6M project included surface rehabilitation of 7.5 miles of Riverside Parkway with a 2-inch mill & overlay, placing 26,000 tons of SX material. The paving was completed at night to help minimize impacts to the community. The City offered bonuses to keep the construction impacts as minimal as possible. Through careful planning, communication and execution, United Companies was able to deliver the project on schedule to meet the incentive.

The project received near perfect to perfect scores in four of the criteria including; overall appearance, segregation, ride quality and transverse joints.

CATEGORY - Quality in Asphalt Production over 100K tons



SIMON of Cheyenne, Wyoming has been recognized with a Colorado Department of Transportation state wide Quality in Asphalt Production Award in the Greater than 100,000 ton Category.

In 2002, CDOT began to monitor the quality of plant-produced asphalt paving mix from each supplier to their construction program. The goal with this effort was to identify and acknowledge the asphalt producer who most consistently meets CDOT's specification requirements. In 2017, there was approximately 1.62 million tons of asphalt materials placed by contractors on state highways. SIMON produced approximately 210,000 tons of asphalt materials in 2017.

CATEGORY - Parking Lot

Colorado State University Parking & Transportation Services and local paving contractor Connell Resources, Inc. have been recognized with a "Best in Colorado" Quality Award in the Commercial Parking Lot Category for their CSU Parking Lot Program project in Fort Collins.

The focus of this \$1M project was to rehabilitate 11 on campus parking lots with a 2-inch mill and overlay. Many of the lots were milled, paved and striped on the same day. With several large conferences and events during the summer, along with all the new building projects underway, 2017 was one of the most active summers making scheduling and completing the work very difficult.

Colorado Department of Transportation Region 1 and local paving contractor Brannan Sand & Gravel have been recognized with a "Best in Colorado" Quality Award in the Urban Highway Resurfacing Category for their US 40 Colfax Resurfacing project in Denver.

This \$5.2M resurfacing project along Colfax Avenue is a high traffic corridor for buses, pedestrians and cars. During the day, Chato's Concrete updated over 100 curb ramps for ADA compliance. Originally designed for a SX100 76-28 overlay, Brannan and CDOT partnered through value-add change order to upgrade the mix to ½" SMA to extend the service life of the pavement. The majority of the milling and paving was completed at night in conjunction with a noise variance granted by Denver. The milling was performed by Alpha Milling. Placement of 16,000 tons of asphalt was completed 25 days ahead of schedule on a 155-day contract. Additional project support was provided by RJ Pagan, Shannon & Wilson and the City of Denver and the project would not have run as smoothly without their contributions.

This \$6M resurfacing project consisted of placing 12 miles of chip seal and an additional 13.5 miles of SX overlay for a total of 36,000 tons of asphalt. Work began in March and was completed in 109 working days.

SH 65 is a two-lane highway known as the Grand Mesa Scenic Byway. The western portion of the project runs along a narrow valley and Plateau Creek heading towards the town of Mesa. The eastern portion of the site leads up to towards the Powder Horn Ski Resort at an elevation of 8,000 to 10,000 at the summit.



Unlike many other airports, Centennial has 3 runways and the runway being rehabilitated was the largest of the 3 serving the majority of the typical jet traffic. This project was accomplished safely and timely despite the fact that this Centennial is one of the busiest general aviation airports in the nation."

The paving portion of the project was originally scheduled to be complete in July 2018, instead the paving was completed on October 26, 2017, a full eight months ahead of schedule.


CATEGORY - In-Place Recycling

A total of 51,000 tons of asphalt was placed. The project began in May and was completed 15 days ahead of schedule on a 120-day contract. The Coughlin Company provided the Cold In-Place Recycling and milling services and was a contributor to the overall success of the project.

The judges provided this interesting story "When we were getting our Starbucks early in the morning in Cortez on the way to inspect the site, both baristas commented on what a good job this is, specifically the transverse joints at the match line with the existing concrete."

Land Use Decisions: Understanding the benefits of construction materials facilities

It's becoming tougher and tougher for contractors and sand/gravel operators to obtain permits for new gravel pits in Colorado. CAPA is routinely supporting our members in these efforts. The opposition is becoming more organized, emotional and consistently taking extreme positions in opposition. Here are the public comments from CAPA Executive Director Tom Peterson from a recent public hearing in front of a board of county commissioners.

"The days of surface mining (or opening new gravel pits) are over." "Why can't you just go someplace else?"

Good evening my name is Tom Peterson, I'm the Executive Director of the Colorado Asphalt Pavement Association. We are the statewide trade association representing the asphalt industry of Colorado. Each year in our state, approximately 8 million tons of aggregates – sand and gravel and mostly from gravel pits - are mined, blended with liquid asphalt and placed as asphalt pavement. Over 90% of all roads in Colorado are asphalt and approximately 95% of asphalt pavement is stone, sand, and gravel.

I'm here tonight to provide feedback to a couple of comments that have been made by those in opposition to this application. Those comment are "The days of surface mining (or opening new gravel pits) is over," and "Why can't you go somewhere else?" Repeating those 2 sayings is like saying, the days are over for new schools, playgrounds, swimming pools, running tracks, new homes, fixing our streets, placing new sidewalks, constructing new shopping centers, everything, is over." All forms of construction require materials and sand and stone from gravel pits is needed in virtually all of them. No more gravel pits – no more construction. The pits are located where the gravel is and that is along the river and watersheds.

The United States Geological Survey has completed a study entitled Planning for the Conservation and Development of Infrastructure Resources in Urban Areas – Colorado Front Range Urban Corridor, the study concluded that: Demand is skyrocketing; deserves are being depleted at record levels; costs are increasing at double digit yearly rates; and finally, decisions made in the near future will have long-term effects on the continued availability of reasonably priced aggregate in the project area and the entire region.

So, saying go somewhere else or that the days of surface mining are over or no more gravel pits is kind of like saying, I have my slice of the American Dream, but I'm not concerned about the rest of the county or my kids and grandchildren.

There is a lot of excitement and support for CDOT's plan to widen I-25 to three lanes from State Highway 402 to Ft. Collins. Last fall, all three short listed contractors submitted bids that were above the guaranteed maximum price and all three bids were rejected. The contract is being awarded for \$40 M above the project estimate. One of the most significant factors leading to the higher project costs is construction materials.

In summary, the history of Colorado includes surface mining – always has. Local available aggregates in the form of gravel pits are part of the

fabric of every community in the state. I would encourage all involved to flip the conversation around from an "us against them" to "how can we co-exist for the benefit of our children and grandchildren?" With that, thank you for your attention and consideration of these comments.


Planning for the Conservation and Development of Infrastructure Resources in Urban Area – Colorado Front Range Urban Corridor Things Planners, Decision Makers, and the Public Should Know.

Future Outlook

The steady increase in aggregate production and use that have occurred in the Front Range urban corridor since the 1950's is expected to increase. Even if large construction projects were to cease, demand for aggregates can be expected to continue at reasonably high levels due to projected population growth and demand for infrastructure improvements and maintenance associated with that growth.

Although the project area has an abundance of aggregate resources, recoverable resources are being hauled from greater distances as local resources become depleted or inaccessible. The tonnage of aggregate being locally permitted for extraction has steadily decreased over time, and the area has been producing more aggregate than it has permitting in new resources since 1994, which is a net decrease in available reserves. If this trend continues, aggregate operators may be forced to move to resource areas even farther away from local markets, resulting in higher transportation costs. Increased costs for this aggregate would be passed along to State or counties as higher construction bids, to the consumer in the form

of higher taxes, user fees, and purchase prices.




CATEGORY - Smoothest Pavement III



CAPA Excellence in Program Delivery Award

E470 Highway Administration, Kraemer North America and Martin Marietta Metro

The E470 Public Highway Authority, Kramer North America and local paving contractor Martin Marietta Metro have been recognized with CAPA's "Excellence in Program Delivery" Award.

This award recognizes the E470 Highway Administration for their program management in addressing long term capacity, serviceability and maintenance with a proactive approach. Construction of their recent 6-mile widening project demonstrates E470's commitment to be the premier urban highway corridor serving the Denver metro area.

This \$78M project consisted of earthwork, grading, drainage, structure widening (11 bridges), full depth asphalt pavement to widen E-470 to 8 lanes, profile milling and SMA overlay paving along the 8-mile stretch between Parker Road and Quincy Avenue. 133,000 tons of hot mix with an additional 78,000 tons of SMA was placed. Kraemer North America was the general contractor and completed the bridge work while SEMA Construction completed the earthwork and grading. Prior to paving, the subgrade was cement treated by Son Haul. Additional contributions were provided by Ground Engineering (QC testing), Kumar & Associates (QA testing) and FHU (engineering design).

Partnering with Kraemer and E470, the team decided to complete the paving over weekends which allowed extended hours and increased closures. Martin Marietta committed to complete the SMA paving in echelon to provide E470 with a superior result. In the end, the project delivered and exceeded all of E470's expectations.
