Trends for 2020

- Over 62,000 lane miles managed by Local Agencies captured in this survey.
- Representing **94%** of Local Agency asphalt paved roads statewide.
- **Over \$302M** budgeted for Annual Street Improvement Programs.
- Over \$317M budgeted for Capital Improvement Programs.
- Mill & Overlay programs increased funding on average **+6%** vs. 2019.
- Maintenance programs maintained funding levels vs. 2019.
- Funding \$ / lane mile decreased
 -2.5% from \$4,973 in 2019.
