

Trends for 2019

- Over 59,000 lane miles managed by Local Agencies captured in this survey.
- Representing **89%** of Local Agency asphalt paved roads statewide.
- **Over \$294M** budgeted for Annual Street Improvement Programs.
- Over \$339M budgeted for Capital Improvement Programs.
- Mill & Overlay programs increased funding on average **+11%** vs. 2018.
- Maintenance programs increased funding on average **+200%** vs. 2018.
- CIP programs increased funding on average +22% vs. 2018.
- Funding \$ / lane mile increased
 +8.3% from \$4,588 in 2018.
